

TIMELINE: Erin Wastewater Treatment Plant

The plant has been a concept for more than a decade

Discussions surrounding the development of a wastewater treatment plant in Erin have been ongoing for more than a decade. But as the project is closer to being realized, more details have become available. Many of these details have caused

The town and developers such as Solmar have indicated that a plant is necessary to allow for growth, and that growth has been mandated provincially.

Here is a timeline of events so far:

May 9, 2017

Council discusses Hillsburgh sewer plant

Councillors were split during a town meeting about whether they should move toward one or two wastewater plants — one in Hillsburgh and one in Erin.

June 27, 2017

Population projections questioned at Erin wastewater meeting

Concerns about major additional population growth in Hillsburgh and Erin — beyond the 10,000 new residents already considered feasible in the next 20 to 30 years — were expressed at a public meeting.

Jan. 15, 2018

Erin wastewater plan needs public input

"Providing wastewater services within our community is no longer a matter of if, but when — the status quo is no longer an option," said Mayor Al Alls in an open letter to residents.

Erin rejects wastewater cost cuts

April 10, 2018

Erin dips into reserves for unbudgeted costs

The Town of Erin used reserve funds to cover an operating deficit of \$62,924 for 2017, plus an unbudgeted total of \$693,388 to complete the Wastewater Environmental Assessment.

April 18, 2018

Mixed messages on Erin wastewater cost sharing

Residents who would not get wastewater service for their homes continued to get conflicting messages about whether they would have to help pay for the system.

May 1, 2018

Ministry to mediate on Erin wastewater objections

Erin wastewater study appealed

An appeal to the province could delay the completion of Erin's wastewater environmental assessment (EA) by a few months, but the town continued developing plans for new growth.

Nov. 20, 2018

Solmar Developments files appeal to province against town of Erin

More than six years ago, Solmar Developments came to the Town of Erin with a proposal to build a subdivision on a 116-hectare parcel of land in the village of Erin.

"They presented the town with an application that was premature," Mayor Alls said.
"We didn't have wastewater."

Ministry of Natural Resources and Forestry warns Erin about impact on brook trout with wastewater plans

The Ministry of Natural Resources and Forestry warned the Town of Erin about the potential impact of wastewater run-off on brook trout populations in the West Credit River.

Sept. 4, 2019

Province gives Erin wastewater green light

The Town of Erin was given the go-ahead from the province to build a wastewater system that would accommodate growth of up to 14,000 residents by 2041.

Oct. 16, 2019

Erin hears options for wastewater financing

The preliminary numbers were in, and while it was unclear how much it would cost existing homeowners, wastewater servicing to new homes would cost anywhere

Belfountain residents petition to halt Erin Wastewater Treatment Plant

The Belfountain Community Organization launched an online petition calling on the town to cease plans for a wastewater system and ease up on their development projections.

A Caledon resident filed a complaint with the Ontario Ombudsman against the Town of Erin following a closed-session meeting on plans for a wastewater treatment plant.

May 5, 2020

Town of Erin poised to award \$1.5M contract for wastewater treatment plant design

The tender for designing the wastewater treatment plant came back, and council looked at awarding the contract to WSP Canada Group Limited for the design portion, for a bid of \$1,533,553.73.

May 13, 2020

Erin residents calling for referendum on wastewater plant decision

Some residents had concerns about the capacity of the river to accept the effluent, as the town was projected to grow to up to 14,500 residents by 2041.

Breaking down the municipal and personal costs of Erin wastewater treatment plant

However, residents would have to pay for the personal costs of hooking up to the system, a portion of the costs of the system and to decommission their current septic tanks.

Oct. 28, 2020

Erin drafts agreement with 10 developers to pay for entire wastewater treatment plant and trunk lines

"Essentially, the money will be enough to build the wastewater plant and the major trunk lines," said Mayor Alls, explaining that the developers are paying development charges now, which would regularly be expected closer to starting their projects.

Ontario River Alliance says town has 'dismissed' plan to protect Credit River brook trout from Erin wastewater plant

"We are really concerned about whether the brook trout could survive," said Linda Heron, chair of the ORA.

Nov. 23, 2020

ANALYSIS: In the budget, not the tax bill: How wastewater plant will impact 2021 Erin budget

The wastewater project was the town's heaviest capital expense, but it wouldn't be reflected on the proposed one per cent tax levy increase for 2021, which equated to a hike of about \$18 for the average property owner with a home valued at \$600,000.

Locals take a stand against wastewater plant

"When this idea for the initial studies was first brought up, there was a town meeting, and there's not one Erin resident that spoke in favour of this," said Ed Delaporte.

"I can barely afford to live in this town as it is," said Tom Feeney, a resident who was with Cowling at the property during the car rally. "It's already too expensive to live in this town. We all have our reasons to be out here, whether it's for the environment or the cost of living. I'm out here for both."

Dufferin-Caledon Greens, Conservatives file petition against waste water treatment plant

Stefan Wiesen, president of the Dufferin-Caledon Green party, and Kyle Seeback, Conservative MP for Dufferin-Caledon, has agreed to sponsor the petition to the federal government and will work together to solicit the 500 signatures required to present it to parliament.

March 18, 2021

Erin council has first look at design of wastewater treatment plant

Council had its first look at the facility design in a WSP Canada Group presentation, which is 75 per cent complete.

Jonathan Wilkinson, federal minister of environment and climate change, has determined the project does not warrant designation under the impact assessment act.

Ottawa's decline of Erin wastewater treatment plant review quashes 'best chance to make real change'

Groups concerned with the health of local waterways say the Canadian government's decision that will pause Erin's proposed wastewater treatment plant review dashes the best hope they had to protect a fragile ecosystem.

Coalition of West Credit River proposes alternative option for Erin wastewater treatment plant

The Coalition for the West Credit River recommends an in-ground, indirect infiltration of the final effluent through an extensive underground perforated pipe system.

According to the Town of Erin, the practice has been looked at, but it has not deemed it necessary to adopt at this time.




